Plan

A forest management plan, signed by a forestry engineer indicating:

- the identification of the property owner and (either on a forest map or aerial photograph) the property on which the concerned wooded area is located as well as the outline of the targeted wooded area and various forest stands;
- the year of the last cut, by sector, if necessary;
- a description of each forest stand and constraints related to the nature of the land or the presence of wildlife habitats;
- a description of the silvicultural treatments planned for each forest stand;

Silvicultural prescription

A silvicultural prescription indicating:

- the owner's objectives, namely:
 - the development of the forest;
 - the development of wildlife;
 - maple production;
 - recreation areas;
 - others (specify);
- the delimitation of the area to be cut;
 - the nature and description of the work;
 - the expected dates of the beginning and the end of the works;
 - the planned regeneration or planting measures, if applicable;
